### Working with the Dispatcher – Part 4 Stephen C. Wood

Readers who have followed this series have arrived at the point at which a train returns to the yard where it started. If this occurs near the end of the operating session, that train will probably be put into a staging area. It will be picked up again at the start of the next session. At this point, the engineer hands his car cards to the yardmaster: he needs these to do his job. Time permitting, the train crews will begin breaking up that train to classify the cars and assign them to their next trains. It is for this purpose that it is essential to surrender the cards upon arrival at the termination point.

When entering a yard, the engineer should always ask the yardmaster where to stop. It is often best to be told where the caboose or final car should end its journey. In any event, the engineer who has looked at his cards and remembers pertinent information can tell the yardmaster how many setouts he is bringing to that facility. The yardmaster, who knows the railroad better than any of its engineers, has alreadv begun the mental process of classification and reassembly.

Always ask permission to enter a train yard. Ask where to stop, and be sure to stop at the yard limit before proceeding. These are combinations of courtesy and yard safety. Occasionally, the yardmaster will uncouple your engine and then issue directions for your movement. From that point forward, the yard crew is responsible for your cars. An alternate scenario is for the yardmaster to uncouple the engine, send it to the rear and have it pick up the caboose.

The engineer may now receive a new set of cards, indicating cars to be picked up and their destination. The engineer must remember to **keep the cards in train order.** Now the dispatcher is called and will be informed that the yardmaster is done with this engineer: the dispatcher is the person who gives further order to continue on whatever way is appropriate.

Wherever he is at the end of these procedures, the engineer must be certain that the dispatcher knows where he is and where he has been! If that engineer is through for the current operating session, he places his cards in the appointed box or on a clothespin, and informs the dispatcher that his work is done. At this point, the engineer may wish to speak with other club members about what he has been doing and to ask advice or opinions. In so doing, he should **never** distract another operator who is working. At the end of a session the owner or club president or trainmaster may wish to hold a general session to discuss that day's operations. Interface with other engineers at this point in time, which may yield information about additional layouts where visiting operators may work and learn. Invitations to other points frequently follow such conversation.

When it is time to leave, a visiting engineer should **always** make a point of thanking the owner for the privilege. It is also proper to ask whether this engineer might come again. One absolute critical factor governing the reply is often the question, **did this visitor make a point of working with the dispatcher and kept him informed at all times?** I hope that the answer to that question as well as the return question is, **YES**.

In addition, this is the end of the series I have been writing about for the past few months. I hope everyone has enjoyed this series and I have said something that has helped someone.

### **Business Meeting**


Grif Bond reviewed the Board of Directors meeting.


